

These are the rules governing the "12 Weeks of Christmas" contest aired on WMXZ-FM/Mix 95.9FM, WCKN-FM/92.5 Kickin' Country/, 101.7 Chuck-FM/WAVF-FM, and Star 99.7, WXST-FM, radio and on the mix959.com, 925kickincountry.com, 1017chuckfm.com, and star997.com websites, unless otherwise specified. All Charleston Radio Group stations will be participating in this promotion. Listeners can participate, and win, by listening to any of the Charleston Radio Group stations:

- 1. No purchase is necessary to enter any 92.5 Kickin' Country contest.
- 2. You must be at least 18 years of age, a legal resident of South Carolina and have a valid South Carolina driver's license to enter and win.
- Beginning Monday, October 2, 2023 at 8:00AM and continuing each Monday through Thursday through, December 14, 2023 at 11:59PM, individuals will be able to listen to any of these four (4) Charleston Radio Group radio stations – WMXZ-FM, Mix 95.9, WXST-FM, Star 99.7, WCKN-FM, 92.5 Kickin Country, and WAVF-FM, 101.7 Chuck-FM – to win.
- 4. Listeners will be competing with other listeners from all four (4) of these Charleston Radio Group stations for the same prize.
- 5. Individuals that are employees or affiliates of Hyundai of North Charleston or Hyundai of Charleston are not eligible to enter and/or win.
- 6. Each Monday through Thursday during the contest period, at approximately 8AM, 11AM, 1PM, 3PM and 5PM, each station will announce a winning keyword. Listeners can text that word to 43414 as many times as they wish to be entered to win \$500 cash and the "12 Weeks of Christmas" grand prize. Standard text and data charges may be applied.

Individuals may also enter to win during the contesting period by visiting Hyundai of North Charleston, 8485 Rivers Ave, North Charleston, SC 29406 or Hyundai of Charleston, 2492 Savannah Highway, Charleston, SC 29414 and scanning a QR code at the dealership during regular business hours, Monday through Friday 9AM until 8PM and Saturday 9AM until 7PM. There is a limit of one (1) QR code entry per household per dealership location per day.

Each entry provides an individual an opportunity to win that week's \$500 cash prize, and the "12 Weeks of Christmas" grand prize, a 36-month, 30,000 mile lease on a 2023 Hyundai Kona SE AWD from Hyundai of Charleston, 2492 Savannah Highway, Charleston, SC 29414. - 11. That winner will be contacted immediately after being selected as the winner. At least three (3) attempts will be made to contact that person at the number the text was received from or the phone number provided on the QR code entry within 1 hour of being selected. The winner will have 3 hours to respond. If the winner does not respond, that \$500 will not be awarded.

The winner will be required to visit Hyundai of North Charleston, 8485 Rivers Ave, North Charleston, SC 29406 or Hyundai of Charleston, 2492 Savannah Highway, Charleston, SC 29414 during regular business hours within seven (7) days of winning to claim their \$500 prize. At least three (3) attempts will be made to contact that person at the number the text was received from or the phone number provided on the QR code entry within 6 hours of being selected.

- 15.
